UNAUDITED OPERATING STATISTICS FOR NOVEMBER 2021

The board of directors (the “**Board**”) of Zhenro Properties Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that during the month ended 30 November 2021, the aggregate contracted sales of the Group, together with its joint ventures and associates, amounted to approximately RMB9.926 billion with contracted gross floor area sold of approximately 608,320 square meters. The contracted average selling price for the month ended 30 November 2021 amounted to approximately RMB16,300 per square meter.

For the eleven months ended 30 November 2021, the aggregate contracted sales of the Group, together with its joint ventures and associates, amounted to approximately RMB135.631 billion, the aggregate contracted gross floor area sold amounted to approximately 8,206,670 square meters and the contracted average selling price was approximately RMB16,500 per square meter.
